

#### **Resistance to Change**

Many team members may prefer existing processes, or they simply don't understand the benefits of deviating from current practices.



#### **Apprehension About New Tech**

New systems can seem daunting, and uncertainty and unfamiliarity with tech can lead to reluctance.



#### **Adoption Timeline**

Adjusting to new workflows requires extra time and patience.

#### **Great Communication**

Clear, ongoing dialogue as early as possible about the change will allow partner agency leadership to make a case for why and how this makes for a better future.



#### **Get Everyone Involved**

Engaging partner agencies early and often in the implementation process will build trust and awareness.




#### **Consistently Showcase Benefits**

Emphasize how a digital evidence management system streamlines operations for all partners. Help them see the risks of standing still.



## Champion a smooth transition

While Guardify is designed to be simple and intuitive for any user, successfully transitioning to a new evidence management system involves more than just technical implementation. To encourage lasting adoption, you have to properly prepare your entire team for change. Following is an outline of essential strategies to help you facilitate a smooth transition for your MDT. These practical steps will guide you to ensure that your team is ready, informed and confident in making this transformative and beneficial shift.





#### Assemble a committee

Gather a small group of key decision-makers. We suggest including a member of the DA's office, CPS, and three to five law enforcement officers from your largest jurisdictions. Conduct group meetings to discuss Guardify's features and benefits, and showcase Guardify in action to familiarize the team.



### Create workflows and a rollout timeline

Work together to determine your workflow for custodianship and user privileges. Then, create a timeline for rolling it out to key team members, including a list of resources each partner may need to help them through the transition.



#### **Encourage feedback**

Create opportunities for team members to voice concerns, questions and suggestions. Ensure that your leadership has time to be approachable and responsive to feedback

## Key steps to getting everyone on board

Rolling out a new system like Guardify does not have to feel like an insurmountable task. Once you have your committee of champion leaders up to speed, you can take these key steps to get every member of your MDT on board. No matter the size of your CAC, these action steps will help you seamlessly integrate your new digital evidence management system, fostering an efficient and collaborative environment ready for a future of protecting children.





#### Introduce key leaders first

Start by getting in front of key decision-makers at each partner organization. Show them what you love about the system and explain clearly why this switch is so important. Your committee should be a united front against pushback.



#### Provide a robust training

Lean on your Guardify customer success team to ensure comprehensive training for all team members.



#### Plan a segmented rollout

Provide gradual exposure to your MDT members. If you work with multiple jurisdictions, implement a slow rollout process, onboarding one or two at a time. This gives you time to work out issues or concerns as they arise. Be prepared to make adjustments based on feedback and evolving needs.




#### Stick to your timeline

Once you create a timeline, communicate it and stick to it. This is the best way to keep all partners aligned.



#### **JANUARY 1**




Guardify account is active and you can begin creating user accounts.

#### **JANUARY 4**




Forensic interview team begins uploading and sharing interviews.

## Measuring success and impact

Transformative change can't stop at implementation. Your leadership committee should set clear goals and expectations to quantify the effectiveness of your new digital evidence management system. This will go a long way to solidifying positive, long-lasting changes in the way your MDT operates for the safety and security of children.

Here are suggestions for defining relevant success metrics and benchmarks, and how to monitor your progress to ensure continuous improvement.



#### **Define Success Metrics**

**Efficiency Gains:** Establish current average case processing times before implementing Guardify. Use this as a baseline to measure improvements.

Adoption Rates: Monitor how many team members start using Guardify within the first few weeks of introduction. Evaluate how comprehensively team members are using Guardify's features over time. Then regularly solicit feedback to assess comfort levels and identify areas that need additional training or support.



#### **Measure Progress**

**Establish Check-Points:** Bring your committee together every six months, or at an interval that works for your MDT, for formal reviews of Guardify's usage and impact.

**Problem-Solving:** Establish a process for quickly addressing issues or bottlenecks to continuously improve the system's use and effectiveness.


